



GUEST ACKNOWLEDGEMENT OF RISKS & USE OF IMAGE

In consideration of the services of LMNRA Guest Services, LLC dba Hoover Dam Rafting Adventures, their officers, agents, employees and volunteers (hereinafter collectively referred to as HDRA):

I understand and agree that although HDRA has taken reasonable steps to provide me with the appropriate equipment and skilled guides so that I can enjoy an activity for which I may not be skilled, HDRA has informed me that this activity is not without risk. These inherent risks are some of the same elements that contribute to the unique character of this activity and can be the cause of loss or damage to my property, accidental injury, illness, or in extreme cases, permanent trauma or death. HDRA does not want to frighten me or reduce my enthusiasm for this activity, but believes it is important for me to know in advance what to expect and to be informed of the inherent risks. The following describes some, but not all, of those risks: slipping, tripping, falling, exposure to heat, exposure to cold water, encounters with wildlife, exposure to vegetation which may be poisonous, falling rocks and debris. In addition, I understand that my property, including, but not limited to, shoes, clothing, cameras, and video equipment, may be damaged by exposure to water, dirt, dust, etc., either inside or outside of the raft or by sudden movements by the raft or other passengers. _____ (initial)

I am aware that traversing through the desert climate weather by foot or on a raft entails risks of injury or death to any participant. I understand that the description of these inherent risks is not complete and that other unknown or unanticipated inherent risks may result in injury or death. My participation in this activity is purely voluntary, no one is forcing me to participate, and I elect to participate with full knowledge of the inherent risks. I acknowledge that the staff of HDRA has been available to more fully explain to me the nature and physical demands of this activity and the inherent risks, hazards and dangers associated with this activity.

I certify that I am fully capable of participating in this activity. I certify the same for any minor children in my care, custody and control.

I, therefore, assume and accept full responsibility for myself (including all minor children in my care, custody, and control) for bodily injury, death, or loss of or damage to personal property and expenses as a result of those inherent risks and dangers identified herein and those inherent risks and dangers not specifically identified.

USE OF IMAGE: I agree that HDRA may take photographs or videos of me (or any minor on whose behalf I sign) and use the image(s) in its promotional materials and publicity efforts, including but not limited to billboards, brochures, magazines, websites, social media, and any and all other promotional materials related to HDRA.
